

BIBLIOGRAFIE

Churchilův život je v popředí trvalého zájmu vědců a veřejnosti téměř sto let. Díla o něm naplnila svazky – viz Frederick Woods (1969 ed.) *A Bibliography of the Works of Sir Winston Churchill* – a každý autor, který se odváženě pustil do studia Churchilla, musí uznat svůj dluh vůči těm, kteří jej předešli. To je zvláště patrné z oficiální biografie a její „Companion Volumes” (podrobně pod Randolph S. Churchill a Martin Gilbert). Ačkoliv byla již tato výpravná biografie zkompletována, je tento mamutí projekt stále rozšiřován o další díly, které budou zahrnovat období po roce 1939. Tyto svazky představují nejen vydání archivních pramenů k Churchillovu životu, ale také k britské a světové politice obecně. Stejně jako ostatní, kteří studují Churchilla, jsem je plnil ku prospěchu i potěšení. Ke konci svého bádání jsem dostal povolení prozkoumat Churchillův archiv, umístěný v Churchillově koleji v Cambridge. Zahrnuje 5 000 svazků, které obsahují přibližně půl milionu stran dokumentů. Všechny citace CHUR, WCHL, CHAR odkazují na tuto sbírku. Z každé návštěvy v archivu bylo zřejmé, že mnoho důležitých materiálů je obsaženo v „Companion Volumes”, zvláště těch, které se týkají meziválečného období. Proto jsem dal přednost citacím z „Companion Volumes”, které jsou pro čtenáře v knihovnách snadno dostupné.
