Texts and Translations

The Greek text of Plato is collected in five volumes published by Oxford University Press (Oxford Classical Texts—OCT), edited by J. Burnet (1900–7). These are gradually being replaced with new editions, the first volume of which has appeared, edited by E. A. Duke, W. F. Hicken, W. S. M. Nicoll, D. B. Robinson, and J. C. G. Strachan (1995). The Greek texts, with facing English translations, are available in the Loeb library; the translations are of varying quality. The Budé texts are also worth consulting; they contain a Greek text with facing French translations, and short notes. The Clarendon Plato series provides generally accurate translations along with detailed notes. The books in this series include:
