- Aftalion, F. (1990) *The French Revolution: An Economic Interpretation*, Cambridge, Cambridge University Press. A monetarist account of the economic history of the Revolution.
- Baker, K. (1990) *Interpreting the French Revolution*, Cambridge, Cambridge University Press. A collection of articles which prioritise the political and the cultural, by one of the leading revisionist, intellectual historians.
- (ed.) (1987) *The French Revolution and the Creation of Modern Political Culture*, vol. 1, *The Political Culture of the Old Regime*, Oxford, Pergamon Press. The 'Chicago School' of revisionist historians offer their interpretations of the Revolution.
- Blanning, T. (1989) *The French Revolution: Aristocrats versus Bourgeois?*, London, Macmillan. Short, sparky, and neo-revisionist.
- Bosher, J. (1989) *The French Revolution*, London, Weidenfeld & Nicolson. An original textbook which shadows the revisionist line: good chapters on the State and the economy.
- Bossenga, G. (1991) *The Politics of Privilege: Old Regime and Revolution in Lille*, Cambridge, Cambridge University Press. Refreshingly new approach, focusing particularly on fiscal matters, to the relationship between Paris and a major, textile town.
- Brugière, M. (1986) *Gestionnaires et profiteurs de la Révolution*, Paris, O. Orban. Most welcome addition to our knowledge of the financial elites during the Revolution. Very useful 'pen-portraits'.
- Chaussinand-Nogaret, G. (1985) *The French Nobility in the Eighteenth Century: From Feudalism to Enlightenment*, trans. W. Doyle, Cambridge, Cambridge University Press. Original, but ultimately unconvincing account of the 'revolutionary' role of the French nobility in the creation of an eighteenth-century 'elite', central to the revisionist, anti-marxist case.
- Cobb, R. (1978) *Death in Paris, 1795-1801*, Oxford, Oxford University Press. Death visited by one of the great social historians of the Revolution.
- (1987) *The People's Armies*, trans. M. Elliott, New Haven, Yale University Press. Classic work on the 'Popular Movement-in-Arms'.
- Cobban, A. (1964) *The Social Interpretation of the French Revolution*, Cambridge, Cambridge University Press. The 'father of revisionism' asks the right questions about the marxist interpretation of the Revolution and offers wrong answers.
- Comninel, G. (1987) *Rethinking The French Revolution: Marxism and the*

- Revisionist Challenge*, London, Verso Books. An uneasy, but challenging attempt to marry historical materialism to revisionism.
- Crouzet, F. (1985) *De la supériorité de l'Angleterre sur la France: l'économique et l'imaginaire, XVIIe-XXe siècles*, Paris, Perrin. Collection of articles by one of the leading French economic historians.
- Doyle, W. (1989) *The Oxford History of the French Revolution*, Oxford, Oxford University Press. Judicious, comprehensive, and balanced, a fine example of the English, liberal, empiricist tradition, revisionist in tone rather than in content.
- Edmonds, W. (1990) *Jacobinism and the Revolt of Lyon, 1789-1793*, Oxford, Oxford University Press. Distinguished by its research base and its dialectical account of the Paris-Lyon tragedy.
- Fehér, F. (ed.) (1990) *The French Revolution and the Birth of Modernity*, Berkeley, University of California Press. The most interesting of the many collections of articles conceived during the Bicentennial commemoration of the Revolution, with contributions from historians as ideologically divided as Eric Hobsbawm and François Furet.
- Forrest, A. (1981) *The Poor in the French Revolution*, Oxford, Oxford University Press. General survey of the major social problem confronting the Revolution.
- and Jones, P. (eds) (1991) *Reshaping France: Town, Country and Region During the French Revolution*, Manchester, Manchester University Press. A wide range of historians discussing a wide range of topics.
- Furet, F. and Ozouf, M. (eds) (1989) *A Critical Dictionary of the French Revolution*, Cambridge, Mass., Harvard University Press. 'Write-bites' of the Revolution from a revisionist angle – 'actors', 'events', 'institutions', etc. Few peasants to be seen in its 1,000 pages.
- Gibson, R. (1989) *A Social History of French Catholicism, 1789-1914*, London, Routledge. The best general account of the impact of Catholicism upon nineteenth-century French society.
- Gough, H. (1988) *The Newspaper Press in the French Revolution*, London, Routledge. Very good survey of recent work on the revolutionary Press, Parisian and provincial.
- Hanson, P. (1989) *Provincial Politics in the French Revolution: Caen and Limoges, 1789-1794*, Baton Rouge, Louisiana State University Press. Thoughtful, comparative study of two provincial towns.
- Hesse, C. (1991) *Publishing and Cultural Politics in Revolutionary Paris 1789-1810*, Berkeley, University of California Press. Proves that one can write cultural history without ignoring political and economic issues.
- Hincker, F. (1989) *La Révolution française et l'économie: décollage ou catastrophe?*, Paris, Editions Nathan. Useful quantitative and qualitative account; a corrective to Aftalion's thesis.
- Hunt, L. (1986) *Politics, Culture and Class in the French Revolution*, London, Methuen. The best kind of revisionist history – provocative, original, intellectually stimulating.
- Jones, C. (1988) *The Longman Companion to the French Revolution*, London, Longman. Indispensable filofax of the Revolution.
- Jones, P. (1988) *The Peasantry in the French Revolution*, Cambridge, Cambridge University Press. Excellent survey of the impact of the Revolution upon the peasantry.

- Kennedy, E. (1989) *A Cultural History of the French Revolution*, New Haven, Yale University Press. A very readable textbook which incorporates recent research on the subject.
- Leith, J. (1991) *Space and Revolution: Projects for Monuments, Squares and Public Buildings in France, 1789-1799*, Montreal, McGill/Queen's University Press. The architecture of the revolutionary imagination, complete with 361 illustrations.
- Lewis, G. (1993) *The Advent of Modern Capitalism in France, 1770-1840: The Contribution of Pierre-François Tubeuf*, Oxford, Oxford University Press. The epic struggle of a dynamic, but forgotten, entrepreneur to introduce modern mining to the 'post-feudal' society of the Basses-Cévennes region.
- and Lucas, C. (eds) (1983) *Beyond the Terror: Essays in French Regional and Social History, 1794-1815*, Cambridge, Cambridge University Press. Essays which underline the major contribution of British historians to the provincial history of France during the Directory and Consulate.
- Lucas, C. (1973) *The Structure of the Terror: The Example of Javogues in the Loire*, Oxford, Oxford University Press. Reveals, in some detail, the interdependent cogs of the machinery of repression in the provinces.
- (ed.) (1988) *The French Revolution and the Creation of Modern Political Culture*, vol. 2, *The Political Culture of the French Revolution*, Oxford, Pergamon Press. Another twenty-three reasons why we should believe in the new revisionism.
- Lynn, J. (1984) *The Bayonets of the Republic: Motivation and Tactics in the Army of Revolutionary France, 1791-1794*, Chicago, University of Illinois Press. Military history at its best.
- Lyons, M. (1975) *France under the Directory*, Cambridge, Cambridge University Press. Still one of the best general surveys of the period.
- Petrey, S. (ed.) (1989) *The French Revolution, 1789-1989: Two Hundred Years of Rethinking*, Texas, Texas Tech. University Press. Articles which raise the symbolic and semiotic to the top of the agenda of revolutionary studies.
- Roberts, J. (1990) *The Counter-revolution in France, 1787-1830*, London, Macmillan. Thoughtful and novel approach to the topic.
- Roche, D. (ed.) (1987) *The People of Paris: An Essay on Popular Culture in the Eighteenth Century*, Leamington Spa, Berg Press. Original essay on the impact of a nascent 'consumer culture' on the popular masses.
- Rose, R. (1978) *Gracchus Babeuf: The First Revolutionary Communist*, London, E. Arnold. The best account in English of Babeuf's life and ideas.
- Schama, S. (1989) *Citizens: A Chronicle of the French Revolution*, London, Viking Press. A blockbuster, with some brilliant *aperçus*, from an historian who treats 'the people' with Voltairian contempt.
- Scott, S. (1978) *The Response of the Royal Army to the French Revolution: The Role and Development of the Line Army, 1787-1793*, Oxford, Oxford University Press. One of the best social histories of the *ancien régime* and revolutionary armies.
- Scott, W. (1973) *Terror and Repression in Revolutionary Marseilles*, London. One of the best accounts of the Terror in the provinces.
- Soboul, A. (1989) *The French Revolution, 1787-1799: From the Storming of*

- the Bastille to Napoleon*, London, Unwin Hyman. *The classic marxist textbook on the Revolution; far less determinist than some critics suggest.*
- Sonenscher, M. (1989) *Work and Wages: Natural Law, Politics and the Eighteenth-Century French Trades*, Cambridge, Cambridge University Press. Well-researched, intellectually stimulating, neo-revisionist.
- Sutherland, D. (1982) *The Chouans: the Social Origins of the Popular Counter-Revolution in Upper Brittany, 1770-1796*, Oxford, Oxford University Press. A good example of the socio-economic approach to the counter-revolution.
- Tackett, T. (1986) *Religion, Revolution and Regional Culture in Eighteenth Century France: The Ecclesiastical Oath of 1791*, Princeton, Princeton University Press. Subtle, scholarly analysis of the problems surrounding the Civil Constitution of the Clergy and its implementation.
