

# Biographical Notes

**Niklas Arvidsson.** Jur. kand., jur.lic. jur. dr. (Lund). Niklas Arvidsson is professor of business law at Lund University and has authored books and articles mainly within the fields of contract law and company law.

**Bertil Bengtsson.** Fil. kand., jur. kand. and jur. dr. (Uppsala). Bertil Bengtsson has been professor of private law at Stockholm and Uppsala University as well as adjunct professor at Lund and Luleå University, head of division at the Svea Court of Appeal and Justice of the Supreme Court. He has authored more than 30 books and a large number of articles on tort, insurance, contract, family, real estate, environmental and constitutional law.

**Tova Bennet.** LL.M and Jur. dr (Lund), Postdoctoral Fellow in criminal law and legal empirical studies (University of Bergen). Tova Bennet's main research focus concerns the general part of criminal law, with a specialization on criminal responsibility and the intersection between law, philosophy, and psychiatry.

**Michael Bogdan.** JUDr. (Prague), B.A., LL.M. and jur. dr. (Lund). Professor emeritus of comparative and private international law (Lund). Member and former President of GEDIP (*Groupe européen de droit international privé*), member of the *Institut de droit international* and of the International Academy of Comparative Law. Author of numerous books and articles, mainly in the fields of private international law and comparative law. Affiliated with the Charles University in Prague as a guest professor.

**Mattias Dahlberg.** Jur.kand. and jur.dr (Uppsala). Mattias Dahlberg is professor of fiscal law at Uppsala University and author of books and articles on international tax law and tax law in general. He was Dean of the Faculty of Law, Uppsala University, between 2014 and 2020. Since 2008 he is a member of the Council for Advance Tax Rulings (*Skatterättsnämnden*).

**Ulf Franke.** Jur. kand. (Stockholm), Secretary General of the Arbitration Institute of the Stockholm Chamber of Commerce (SCC) 1980 to 2010. Over these years Ulf Franke has provided arbitration and alternative dispute resolution services in several thousand cases with parties from virtually all parts of the world. Ulf Franke has also been President of the International Federation of Commercial Arbitration Institutions (IFCAI) and Secretary General of the International Council for Commercial Arbitration (ICCA).

**Lars Gorton.** Jur. kand. (Lund), jur. dr (Stockholm), professor emeritus of banking law (Lund). Lars Gorton is currently associated with the Stockholm Centre for Commercial Law at Stockholm University.

**Richard Hager.** Jur. dr (Stockholm), associate professor of private law (Uppsala), currently at Stockholm university. Richard Hager has authored books and articles in contract law, tenant law and other fields of real estate law and land law.

**Torgny Håstad.** Jur. dr. 1973. Associate Professor 1976 and Professor of Private Law 1978-1998 (Uppsala). Dean of the Uppsala Faculty of Law 1994-1998. Supreme Court Justice 1998-2011. Author of books and articles on contracts, quasi-contracts and insolvency law. Chairman of several legislative committees.

**Johan Hirschfeldt.** Jur. kand. (Stockholm), jur. dr h.c. (Uppsala). Johan Hirschfeldt has been Under-Secretary for Legal Matters at the Swedish Government's Cabinet Office, the Chancellor of Justice and President of the Svea Court of Appeal. Johan Hirschfeldt is Chairman of the The Institute for Research in Legal Science.

**Titti Mattsson.** B.A. (George Washington University), jur. kand. and jur. dr. (Lund). Titti Mattsson is professor of public law at Lund University and an author of books and articles on social-welfare law, elder law and child law. She is Director of the Health Law Research Centre at the Faculty of Law, Lund University.

**Lotta Maunsbach.** Jur. kand. and jur. dr (Lund). Lotta Maunsbach is senior lecturer in procedural law and an author of books and articles in procedural law, mainly in the fields of civil procedure and alternative dispute resolution but also in civil law and issues that occur in the intersection between procedural law and civil law.

**Joakim Nergelius.** Jur. dr (Lund), professor of law (Örebro) and associate professor of European and comparative Law (Åbo Academy, Turku). Former civil servant of the EU Court of Justice and Committee of Regions. Joakim Nergelius has published extensively on Swedish and comparative constitutional law, as well as on institutional EU law.

**Annika Nilsson.** Jur. dr (Lund), professor emerita of public law, with speciality in environmental law (Lund). Annika Nilsson's dissertation from 1997 discusses and analyzes the principle of substitution, with regard to chemicals, which is a substantive rule in Swedish law. Currently, she is working with interdisciplinary research on safe handling of nanomaterials.

**Ann Numhauser-Henning.** Professor emerita of private law at Lund University. At the same university, she has been the Pro-Vice Chancellor and Vice-Dean of the Law Faculty. She initiated the Norma Research Programme on 'Normative Development within the Social Dimension' in 1996 and the Norma Elder Law Research Environment in 2012. Her main field of interest are the flexibilization of work, discrimination in employment and social rights of migrant workers in an EU perspective.

**Katarina Olsson.** Jur. kand. and jur. dr (Lund). Katarina Olsson is professor of private law at Lund University and author of books and articles on competition law, foundation law and trust law.

**Christina Ramberg.** Jur. dr. (Stockholm); professor since 1998, currently at Stockholm University. Christina Ramberg is frequently appointed as arbitrator and expert and is author of numerous books and articles, mainly in the fields of contract law and electronic commerce.

**Eva Ryrstedt.** Jur. dr (Lund), professor of private law (Lund). Present dean of the Lund Faculty of Law. Eva Ryrstedt is an author of books and articles in the field of family law, often in a social-law perspective; she also works comparatively with a special interest in the law of the Nordic countries, England and Australia.

**Rebecca Thorburn Stern.** Jur. dr (Uppsala), professor of public international law (Uppsala). She has published extensively on migration law, asylum law, human rights law (in particular children's rights) and the relationship between national and international law.

**Stig Strömholm.** Fil. kand. and jur. kand. (Uppsala), Dipl. Comparative Legal Studies (Cantab.), dr jur. (München), jur. dr (Uppsala), LL.D. h.c. (mult.), Ph.D. h.c. (mult.). At Uppsala University, Stig Strömholm has been professor of jurisprudence, professor of private and private international law, dean of the Faculty of Law, deputy vice-chancellor and vice-chancellor. Stig Strömholm has also been president of the Royal Swedish Academy of Letters, History and Antiquities and president of Academia Europaea.

**Lennart Svensäter.** Jur. dr. (Lund), former president of the Scania and Blekinge Court of Appeal. Lennart Svensäter has been adjunct professor of private law at Lund University and has written books and articles, mainly in the fields of labor law and intellectual property law.

**Hans-Heinrich Vogel.** Dr jur. and Assessor (Hamburg), jur. kand. (Lund), jur. dr h.c. (Lund), professor emeritus of public law (Lund). Hans-Heinrich Vogel has also been associate professor of tax law and of comparative law (Lund) and professor of public law (Stockholm) and is an author of books and articles mainly in the fields of comparative law, commercial law, tax law and public law.

**Henrik Wenander.** Fil. kand. and jur. kand. (Lund), jur. dr (Lund). Henrik Wenander is professor of public law at Lund University and an author of books and articles on Swedish public law in European and international perspective and Nordic legal cooperation. He is co-editor of the peer-reviewed Swedish Journal of Administrative Law (*Förvaltningsrättslig tidskrift*).

**Christoffer Wong.** M.A. (St And.), B.Phil (Oxon.), jur. kand and jur. dr (Lund). Christoffer Wong is senior lecturer in criminal law and procedure at Lund University. Besides Swedish criminal law and procedure his research interests cover comparative, EU and international criminal law.
