- Bechtel, Carol M. 2002. *Esther*. Interpretation. Louisville: John Knox Press.—A treatment of the book of Esther, with attention to theological concerns, for a more generalist audience. Includes comments on the Greek Additions.
- Berlin, Adele. 2001a. *Esther*. The JPS Bible Commentary. Philadelphia: The Jewish Publication Society.—Emphasizes the comedic character of the book of Esther and reads it in light of contemporaneous Greek historiography and midrashic interpretation.
- Bush, Frederic W. 1996. *Esther*. In *Ruth, Esther*. Word Biblical Commentary 9. Dallas: Word Publishing.—A detailed and thorough commentary with various charts delineating the book's structure. Includes philological notes and extensive bibliography.

Nashville: Abingdon Press.—Even-handed commentary on the Hebrew book and the Greek Additions, including discussion of the questions of the book of Esther at Qumran and theological reflections.

Louisville: Westminster John Knox Press.—A brief commentary whose strength lies in its suggestions about the structure of the book of Esther. - Moore, Carey A. 1971. *Esther: Introduction, Translation, and Notes*. The Anchor Bible 7B. Garden City: Doubleday.—Authored by a scholar who dedicated much of his academic career to the book of Esther, this work served as the major modern English commentary for years. Special attention given to the concerns of canonicity and historiography.

Missoula: Scholars Press.—An assessment of certain of the major themes (banquets, kingship, obedience, power, loyalty, reversal) of the book of Esther and a comparison of it with the Joseph story.

Includes an English translation of the Greek A (Alpha) Text.

Louisville: Westminster John Knox Press.—Assessment of the book of Esther as an example of the genre of carnivalesque, as explicated in the scholarship of literary theorist Mikhail Bakhtin.
