Scholarly articles, many by professors from the Gregorian University in Rome.

Pages 1–400 trace the history of apologetics.

Aubert, Roger. *Le Problème de l'acte de foi*. 2d ed. Louvain: Warny, 1950.

Particularly valuable for treatment of Catholic controversies concerning faith and reason in the nineteenth and early twentieth centuries.

Copleston, Frederick. *A History of Philosophy*. 8 vols. Westminster, Md.: Newman Press, 1946–1966.

Perhaps the most useful of the histories of philosophy for material touching on apologetics.

Cristiani, Leon. *Why We Believe: The Meaning and Use of Apologetics*. Translated by Dom Mark Pontifex. Twentieth Century Encyclopedia of Catholicism 106. New York: Hawthorn, 1959.

A brief, popular work useful for its sketches of Augustine, Pascal, Bossuet, Paul de Broglie, and Teilhard de Chardin.

Martin, Jules. *L'apologétique traditionnelle*. 3 vols. Paris: Lethielleux, 1905–1906. Vol. 1, The First Five Centuries. Vol. 2, Seventh through Sixteenth Centuries. Vol. 3, Seventeenth-Century Catholic Apologists.

These three small volumes are intended to back up Blondel's thesis that apologetics must build on subjective and supernatural factors.

Murphy, John L. *With the Eyes of Faith*. Milwaukee: Bruce Publishing, 1966.

Ramm, Bernard. *Varieties of Christian Apologetics*. Grand Rapids: Baker Book House, 1962.

A textbook outlining the approaches of nine representative Christian apologists. Orientation is Conservative Evangelical.

Reid, John K. S. *Christian Apologetics*. London: Hodder and Stoughton, 1969.

A well-written but somewhat cursory treatment of apologetics from the beginnings; gives little attention to Catholics since the Reformation.

Thils, Gustave. *Les Notes de l'église dans l'apologétique catholique depuis la Réforme*. Gembloux: Duculot, 1937.

An in-depth study of the argument for Catholicism based on the four notes of the Church; detailed and critical.

Webb, Clement D.J. *Studies in the History of Natural Theology*. Oxford: Clarendon, 1915.

The latter part deals with Anselm, Abelard, Aquinas, Raymond of Sebonde, Pietro Pomponazzi, and Lord Herbert of Cherbury.

Werner, Karl. *Geschichte der apologetischen and polemischen Literatur der christlichen Theologie*. 5 vols. Schaffhausen: Hurter, 1861–1867.

A voluminous history of religious controversies, especially between the Catholic Church and other Christian groups. Vol. 5 is devoted to apologetics since the seventeenth century.

Williams, A. Lukyn. *Adversus Judaeos: A Bird's Eye View of Christian 'Apologiae' until the Renaissance*. Cambridge, Eng.: University Press, 1935.

Valuable summaries and background concerning anti-Jewish polemics through the centuries; has been criticized for some omissions and for lack of synthesis.

Zöckler, Otto. *Geschichte der Apologie des Christentums*. Gütersloh: Bertelsmann, 1907.

The final work of a distinguished Lutheran confessional theologian in the tradition of Luthardt. This very thorough and judicious history is still of value.

Five lectures very helpful for lining up the apologetical motifs in the New Testament. Reprinted in paperback 1961, 1967.

An important study by a creative theologian of the post-Bultmann school.

Three lectures with an appendix on history and eschatology.

- Harris, J. Rendel. *Testimonies*. 2 vols. Cambridge, Eng.: University Press, 1916-1920.  
Argues for the existence of a *Testimony Book* earlier in date than some of the earliest books of the New Testament.

Latourelle, René. *The Miracles of Jesus and the Theology of Miracles*. Translated by Matthew J. O'Connell. New York: Paulist Press, 1988.

A study of the New Testament evidence and an exposition of the Catholic theology of miracles.

Lindars, Barnabas. *New Testament Apologetic: The Doctrinal Significance of the Old Testament Quotations*. Philadelphia: Westminster Press, 1961.

A very careful study of the apologetical use of Old Testament quotations by early Christians in controversy with Jews.

Moule, C. F. D. *The Birth of the New Testament*. Black's New Testament Commentaries 1. New York: Harper, 1962.

Investigation of circumstances that led to the writing of the New Testament.

Scott, Ernest F. *The Apologetic of the New Testament*. New York: Putnam, 1907.

Argues that New Testament apologetic rests upon a "purely ethical and spiritual" conception of the "absolute worth of the personality of Jesus".
