

## BIBLIOGRAPHY OF RECENT LITERATURE ON THE PASTORAL EPISTLES

The references to articles in periodicals are mostly taken from a trawl through *New Testament Abstracts* 1999–2008, omitting items that appear to be on a devotional level. The abbreviations generally follow SBL guidelines. The vast bibliography on 1 Timothy 2 and related issues is not included. And I personally have not consulted everything listed—not by a long way! This list is material for selective use in an agenda, not an achievement.
