about these issues - revealing a rich lode of distilled knowledge. But in intracting the sorts of principles that can serve as actual guides for managers, is clear there are no easy answers. So much is contingent on the nature and battery of the ecosystem, the organisms or ecosystem processes to be sustamed, and the socio-economic-political context that finding the equivalent of a Boyle's Law for landscape ecology seems highly unlikely. For example, the ecological value of corridors - a classic topic in conservation science - turns out to be fiendishly complex and context-dependent.
