THE AUTHORS

Clark Spencer is currently Professor of Anthropology at the University of North Carolina at Chapel Hill. He has a B.S. in Anthropology from the University of North Carolina and a Ph.D. in Anthropology from the University of Michigan. His research is primarily focussed on bioarchaeology and biocultural adaptation in Holocene human populations. Although his fieldwork and related research is mostly in the southeastern United States, he has been involved in projects in the American Great Basin, New England, Midwest, and Plains, and has studied the skeletons of Neanderthals from Krapine, Croatia, and Neolithic farmers from Greece. He has authored, edited, and co-edited over a dozen books and monographs, including *Advances in Dental Anthropology* (Wiley-Liss, New York), *In the Wake of Contact: Biological Responses to Conquest* (Wiley-Liss, New York), and *Bioarchaeology: Interpreting Behavior from the Human Skeleton* (Cambridge University Press, Cambridge). His articles and other works have appeared in *Current Anthropology*, *Journal of Human Evolution*, *American Journal of Physical Anthropology*, *Human Biology*, *International Journal of Osteoarchaeology*, *Advances in Archaeological Method and Theory*, and *Anthropological Papers of the American Museum of Natural History*.

Robert M. Matter is Professor Emeritus of Art and Anthropology at Sauk Valley College (DeKalb, Illinois). After studying art at the School of the Art Institute of Chicago, he continued in the College of Visual and Performing Arts at Northern Illinois University where he received his B.A. and M.A. degrees. He also received an M.A. in anthropology from that institution.

Daniel L. Gebq is Professor of Anthropology at Northern Illinois University (DeKalb, Illinois). He received his B.S. in zoology from Oregon State University; his M.S. in anthropology from the University of Wisconsin, Milwaukee; and his Ph.D. in biological anthropology from Duke University. His research focusses on primate evolution, with a particular emphasis on locomotor adaptation, functional morphology, and phylogeny. His field research has taken him to the badlands of Wyoming, Uganda, and China, the deserts of Egypt, Mali, and Colombia, and the rain forests of Costa Rica, Uganda, Madagascar, and the Philippines. Results of his research have been published in the *Journal of Human Evolution*, *American Journal of Physical Anthropology*, *Folia Primatologica*, *American Journal of Primatology*, *Primates*, *Science*, and *Nature*. He also edited the book *Postcranial Adaptation in Non-human Primates* (Northern Illinois University Press, DeKalb).
